For and on behalf of the Department of Disaster Management & Civil Defence, Government of West Bengal, sealed Limited Tenders are invited from firms/Govt. Organisation/Semi-Govt. Organisation/Govt. Undertaking having currently valid NABL accreditation whose names are given in the attached list for "Selection of Third Party Organisation for Testing of Clothing and Garments to Ascertain Their Conformity as per Specification" by the Director of Disaster Management& Civil Defence, Government of West Bengal. The firms/organisations other than listed may also participate subject to the fulfillment of eligibility criteria mentioned in this tender.

- 2. In case your firm/organisation is interested in the above process of work, you are requested to quote your competitive price in the enclosed proforma in a sealed cover. The sealed quotation under COVER, should be super scribed "Quotation for Selection of Third Party Organisation for Testing of Clothing and Garments to Ascertain Their Conformity as per Specification" and should be dropped in the tender box kept at 3rd Floor of the office of the Director of Disaster Management, TRAN BHAVAN87A,S.N.Banerjee Road, Kolkata-700014(Tender Inviting Authority) latest by 25/03/2019 upto 3.00 PM by Authorised Representative only. The sealed quotation will be opened on next day, i.e., on 26/03/2019 at 11.00 AM in the presence of Representatives of the vender/firms if they like to be present. The authority reserves all right to accept or reject any quotation without assigning any reason and the decision of the authority in this respect will be full and final.
- 3. Participating firms should go through the terms and conditions and eligibility criteria carefully before submission of their bids. Any query/clarification etc. regarding the terms, condition, eligibility etc. other than financial information will be provided from this office if sought for before the closing date. No withdrawal is allowed after submission of bid.
- Participating firms/organisations should quote their competitive price in the proforma given in Annexure-A.

Tender Information:

- 1. The intending bidders are required to submit their bid in the proforma in scaled cover;
- 2. The two parts, i.e, Technical Part and Financial Part of the Tenders are to be sealed under separate cover; each cover should be super scribbed as Technical Cover and Financial Cover respectively with Tender Notification No. Both the covers are required to be sealed under a COVER super-scribing "Quotation for Selection of Third Party Organisation for Testing of Clothing and Garments to Ascertain Their Conformity as per Specification" alongwith the Tender Notification No.
- Technical Cover should contain all the documents duly attested in support of the eligibility as mentioned below;
- 4. Financial Cover should contain the Financial Part only where rate is to be quoted; Rate cannot be quoted other than Financial Part. Otherwise, bid will be liable to be cancelled.

Terms and Condition:-

I. Pre-qualification Criteria:-

- The intending firm/organisation should have currently valid NABL accreditation for the work;
- The intending firm/ Organisation should have experience in testing of clothing/garment items at least for one year in any organisation/ agency;
- iii. The intending firms/organisations should have Valid GST Registration, valid PAN and necessary clearance from the appropriate authority;
- Registration under Partnership Deed (for Partnership firm only) alongwith Power of Attorney to be submitted with the bid;
- v. The intending firm/organisation should have infrastructure to carry out visual inspection and collect samples for laboratory testing from the Government Relief Store Kolkata on the date of receiving the same at the Godown Points, even on Saturday, Sunday and on Holidays if required;
- vi. The final test report as to the conformity of the materials checked should reach the office of the Director of Disaster Management, govt. of West Bengal within 48 hours after collecting samples;

II. Materials to be checked or inspected:-

The details of the materials required to be inspected alongwith specification is given in Annexure-B for example.

III. Inspection and Testing Procedure:-

- Testing of materials will be done in two ways:- a) Visual Inspection , b) Laboratory Testing;
- ii. Visual Inspection will be done at the Godown point on the date of receiving the same at the Godown point in the presence of the representative of Department and the representative of the Supplier. Visual Inspection will be done to ascertain absence of major defects like holes, torn, stitching defects and non-standard dimension.
- If a lot of supply passes the Visual Inspection, then the samples collected as per Sampling Plan will be sent to the Laboratory for ascertaining the Physical and Chemical Specification.

- iv. The third party testing agency is required to submit a final report depicting clearly the Conformity or Non-Conformity of the materials with the specification after doing Visual and Laboratory Testing within 48 hours of collecting the Samples.
- v. Samples to be checked for both visual and laboratory testing will be collected randomly;
- vi. There will be a Sampling Plan which will be communicated to the selected agency from time to time.
- vii. The criteria of conformity will also be communicated to the selected agency from time to time.

IV. Price:

- 1. Price to be quoted for third party testing in the Financial Bid as a percentage of the value of the materials finally accepted with conformity to the specification and on the value of rejected materials. The value of the materials to be calculated on their basic price only excluding GST. The percentage such quoted is allowed upto two place of decimals. GST as applicable will be charged separately after calculating the percentage value. This percentage value should be firm and fixed leaving no scope of change in future which will be valid for a period of one year. It may be extended for another 6 (six) month on mutual consent of both the parties, if necessary.
 - (A year-wise procurement details for last three financial years is given in Annexure-C to give an idea of total monetary value of materials procure in a financial year.)
- 2. The Department of Disaster Management & Civil Defence also reserves the right to select one or more organisations and award work order for whole or part of its requirement. The Department of Disaster Management & Civil Defence reserves its rights to seek clarification before accepting any offer / tender. The Department of Disaster Management & Civil Defence reserves its right to make counter-offers to other bidders for accepting the L 1 rate and to conclude parallel contracts with them. The L2 bidder may be requested to do the work at the L1 rate. In case of refusal by the L2 bidder, the L3 bidder may be approached at the L1 rate and so on.
- 3. Rate to be quoted for whole work; not for any part of it.

V. Execution of Agreement and Payment of Bill:-

- After finalisation of tender, the successful tenderer is required to execute an agreement at their own cost in a Non-judicial Stamp Paper of value Rs. 500/within 3 working days of issuance of offer letter,
- ii. Terms of Payment:- Payment will be made within three months from the date of submission of bills from the date of submission of bills in all respect. No interest will be paid in case of any delay in payment.
- iii. Submission of Bills:-
 - a. Bills in triplicate in Tax Invoice to be submitted clearly mentioning the Tender No. & date and Work Order No. & Date;
 - Applicable GST, if any should be clearly indicated in each copy of bills;

- Authority reserves all right to accept or cancel any part or whole bill after proper verification of the same.
- iv. The authority reserves all right to cancel whole or any part of the tender at any moment, even after making contract, without assigning any reason.

VI. Jurisdiction Clause:

For litigation or legal issues if any, to be settled at Calcutta jurisdiction only.

VII. General Instruction to the Bidders:-

- The bidder should sign and stamp all the pages of the document.
- The Technical Eligibility along with all supporting documents are to be given under a sealed cover super-scribbed as "Technical Cover",
- iii) The Financial part where rate to be quoted in percentage to be sealed under a separate cover super-scribbed as "Financial Cover".
