NOTIFICATION

Fabricated black polythene tarpaulin sheets are distributed among 500 (five hundred) distressed persons of every Assembly constituency of the State, once in a year, through the Block Development Officer, on the basis of receipt of request of the concerned Member of the Legislative Assembly Constituency, vide this Deptt.'s Notification No. 1267-FR, dt. 14.7.2009.

Some questions on the process of distribution of the said tarpaulins were raised from different corners.

After careful consideration of the matter, the Governor has been pleased to decide that henceforth the said 500 pieces of tarpaulin sheets will be distributed among 500 distressed people of every Assembly Constituency through the concerned M.L.A. every year, and like other M.L.A. quota articles. The quantity of tarpaulin for each M.L.A. will be dispatched to his/her residence/ office address as given by the concerned M.L.A. and the expenditure on this account will be borne by the Department.

This Notification supersedes this Deptt.'s earlier Notification No. 1267-FR, dated 14.7.2009, takes effect from the current financial year and will remain in force until further order.
